Attached please find a calculation of the amount to be refunded to Pacific Valley Housing as a result of the annexation. This refund is due to the annexation of parcels that have already paid Mira fees at \$7,198 per parcel. The refund amount is based on the amount of the Mira fee paid, less a \$500 per parcel administrative fee. As the calculation shows, the present value of the Mello Roos taxes exceeds the amount of the Mira fee for each of the parcels.
